TRANSPHORM INC. END USER LICENSE AGREEMENT

Thank you for your interest in the hardware and software products provided by Transphorm Inc. ("<u>Transphorm</u>"). This End User License Agreement (this "<u>Agreement</u>") governs your use of the Software (as defined below. You may also request a copy by emailing us at info@transphormusa.com.

BY CLICKING "I AGREE" OR BY USING THE SOFTWARE, YOU ("YOU" OR "CUSTOMER") ACKNOWLEDGE THAT YOU HAVE READ AND ACCEPT THIS AGREEMENT, AND THAT YOU ARE AUTHORIZED TO ACCEPT THIS AGREEMENT. Transphorm and Customer hereby agree as follows:

1 Definitions

"<u>Hardware</u>" means the Transphorm hardware products acquired or used by you.

"Software" means the executable code version of the software that came pre-installed on the Hardware or was otherwise provided or made available to you by Transphorm for use in connection with the Hardware, and any bug fixes, enhancements or other updates thereto (collectively, "Updates") that may be provided or made available to you by Transphorm from time to time.

2 License: Restrictions

- 2.1 <u>Software License</u>. Subject to the terms and conditions of this Agreement, Transphorm grants to Customer a nonexclusive, nontransferable, limited license to use the Software, solely in connection with Customer's use of the Hardware, and in accordance with the applicable user documentation, if any, provided by Transphorm.
- 2.2 Restrictions. Customer shall not (and shall not permit any third party to) (i) reverse engineer, decompile, disassemble or otherwise reduce the Software to human perceivable form or attempt to discover underlying source code, algorithms or techniques, except to the extent that such activities may not be prohibited under applicable law, (ii) copy, modify, translate, provide, lease, sublicense, sell, assign, or allow use of the Software by any third party, (iii) disclose any benchmarking, competitive analysis or other results obtained from the Software or use the Software or portion thereof to develop any similar item or any competitive products or services, or (iv) use or remove the Software from any Hardware on which or for which it is provided.
- 2.3 <u>Updates</u>. From time to time, Transphorm may provide or make available to Customer Updates. Customer agrees to promptly install all such Updates.

3 Proprietary Rights; Confidentiality; Indemnity

3.1 Proprietary Rights. The Software is licensed, not sold. Transphorm shall retain ownership of the Software and all intellectual property rights relating thereto. Customer agrees that Transphorm may use and exploit without restriction any error reports, suggestions and other information provided by Customer with respect to the Software and shall own any fixes, modifications, improvements and new versions made by Transphorm based on such information. The Software may contain certain third party software or portions provided under terms and conditions different from this Agreement (such as open source or community source), which may be identified in a text file included with the Software or in a file

- or location referenced thereby or on Transphorm's website, and Customer agrees that such software or portions will be subject to such other terms and conditions to the extent inconsistent with this Agreement or to the extent required by such other terms and conditions. Customer may also contact Transphorm to get all relevant information regarding such third party software. All implied licenses are disclaimed and all rights not expressly granted herein are reserved to Transphorm.
- 3.2 Confidentiality. The Software, documentation and other non-public information provided by Transphorm are confidential to Transphorm and shall not be disclosed by Customer to any third party. The Software in source code form remains a confidential trade secret of Transphorm and/or its suppliers. The Software is protected by the copyright and other intellectual property laws of the United States and international treaties. Customer acknowledges that, in the course of using the Software, Customer may obtain or learn information relating to the Software, which may include, without limitation, information relating to the performance, reliability or stability of the Software. operation of the Software, knowhow, techniques, processes, ideas, algorithms, and software design and architecture ("Proprietary Information"). As between the parties, such Proprietary Information shall belong solely to Transphorm. During and after the term of this Agreement, Customer shall hold in confidence and protect, and shall not use (except as expressly authorized by this Agreement) or disclose, Proprietary Information to any third party.
- 3.3 <u>Indemnity</u>. Customer will indemnify, hold harmless, and defend Transphorm (including all of its officers, employees, directors, subsidiaries, representatives, affiliates, and agents) and Transphorm's licensors and suppliers from and against any damages (including attorney's fees and expenses), claims, and lawsuits that arise or result from Customer's use of the Software.
- 4 Termination. Either party may terminate this Agreement in the event of a breach by the other party that is not cured within 30 days after notice (or 10 days for breach of payment or license restrictions). Transphorm may terminate this Agreement immediately upon Customer becoming insolvent or generally failing to pay its debts as they become due, or commencing or becoming subject to reorganization, insolvency or liquidation proceedings or ceasing to conduct business in the ordinary course. Upon termination, all licenses under this Agreement shall terminate and Customer shall return and cease all use of the Software. Sections 3, Error! OF NONINFRINGEMENT AND **FITNESS** FOR PARTICULAR PURPOSE. TRANSPHORM DOES NOT WARRANT THAT THE SOFTWARE WILL MEET CUSTOMER'S REQUIREMENTS OR FUNCTION UNINTERRUPTED OR ERROR-FREE.
- 6 Limitation of Liability. IN NO EVENT SHALL TRANSPHORM LIABLE **FOR** BEINDIRECT, SPECIAL CONSEQUENTIAL INCIDENTAL, OR DAMAGES (INCLUDING COSTS OF PROCUREMENT OF SUBSTITUTE GOODS) ARISING OUT OF OR RELATING TO THIS AGREEMENT OR THE SOFTWARE, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. TRANSPHORM'S TOTAL LIABILITY ARISING OUT OR RELATING TO THIS AGREEMENT OR THE SOFTWARE WILL NOT EXCEED THE AMOUNT PAID TO TRANSPHORM FOR THE HARDWARE ON, OR IN CONNECTION WITH WHICH, TRANSPHORM PROVIDED THE SOFTWARE, REGARDLESS OF WHETHER ANY REMEDY SET FORTH HEREIN FAILS OF ITS ESSENTIAL PURPOSE OR OTHERWISE.
- 7 Governing Law; Disputes. This Agreement is governed by California law, excluding its choice of laws rule. The United Nations Convention on Contracts for the International Sale of Goods (1980) is specifically excluded and shall not apply. Any dispute or claim arising out of or related to this Agreement, or breach or termination thereof, shall be subject to exclusive jurisdiction, forum and venue of the state and federal courts in Santa Clara County, California, and the

- parties agree and submit to the personal and exclusive jurisdiction of these courts. This Agreement and all proceedings shall be in the English language only.
- **8 Export; FCPA.** The Software may not be exported without prior written consent of Transphorm. Customer warrants and hereby gives written assurance to Transphorm that Customer will comply with all U.S. and foreign export and re-export restrictions applicable to the Software and its documentation and technical information provided hereunder. Company warrants that it shall comply with the Foreign Corrupt Practices Act ("FCPA") in all dealings with, by, for or on behalf of Transphorm, and shall not offer, promise, give, demand, seek or accept, directly or indirectly, any gift or payment, consideration or benefit in kind that would or could be construed as an illegal or corrupt practice.
- 9 Miscellaneous. This Agreement and the rights hereunder may not be assigned or otherwise transferred, either directly or indirectly, by Customer without the prior written consent of Transphorm. This is the entire Agreement between the parties relating to the subject matter hereof and no waiver or modification of the Agreement shall be valid unless in writing signed by each party. The waiver of a breach of any term hereof shall in no way be construed as a waiver of any other term or breach hereof. This Agreement supersedes all pre-printed terms and conditions in any purchase order or other business form submitted by Customer and any inconsistent non-pre-printed terms, all of which are rejected. If any provision of this Agreement shall be held by a court of competent jurisdiction to be contrary to law, the remaining provisions of this Agreement shall remain in full force and effect.
